Commercial Booth Rental Agreement

The Vermont Sheep & Goat Association (VSGA) invites you to join us at the Twentieth Annual Vermont Sheep & Wool Festival. The dates will be September 6th and 7th 2008.

We must have your application by May 1st to guarantee that you will be included in the program booklet, and on the website, although we will keep adding to the listing on the website as applications arrive.

Cancellation policy: For both animal pens and vendor booths, there is a \$20 administration fee for any cancellation. If we are able to fill your space, then you will receive a refund minus the \$20 fee. If we cannot fill your space, then your pen/booth fee will be forfeited.

Booth spaces will be 5' x 5'; 10' x 10'; 10' x 15'; or 10 x 20'. Please keep in mind that the 5 x 5 spaces are not enough space for a regular size table. Set-up information will be mailed out the first week of August, so you have at least 20 days to return your paperwork.

RULES:

- The festival committee reserves the right to reject a booth applicant for lack of suitability and compatibility. Pre-registration does NOT guarantee a space; we will accept vendors on a "festival need" basis, and not a "first-come first-serve" basis. If you are not accepted, we will return your check.
- We reserve the right to reject any vendor who does not treat everyone with courtesy.
- The festival committee, whose decision will be final, shall decide disputes arising from any cause.
- All vendors understand that they are responsible for any commitments they make at the festival.
- All booths must be manned at all times. You are responsible for anyone wearing a vendor tag from your business. All booth material must stay within the boundaries of the designated space. There is no selling allowed outside the booth spaces.
- All vendors are responsible for keeping their space clean at all times, and for cleaning their area at the end of the festival.
- Any vendor who tears down or leaves before the festival ends will not be allowed back the following year.
- Signs and displays shall not be so large as to interfere with the view of the neighboring booths.
- No animals except those that are registered, have proper papers, and in pens are permitted at the festival (NO dogs are allowed...with the exception of service dogs).
